1. The Permanent Mission of India, Avenue Appia 21, 1292 Chambésy, Geneva (hereinafter referred to as the 'Mission') invites sealed quotations from registered companies in Geneva for Annual Maintenance Contract of fire protection system in the Mission.

2. The broad scope of work includes undertaking, for a period of one year from date of award of contract, the maintenance of all components of the fire prevention and protection system installed in the Mission, including all smoke detectors, fire-prevention doors and curtains, and fire extinguishers.

- 3. The interested bidders must fulfil the following conditions:
- (a) The company must be registered Switzerland and have its own establishment comprising of all necessary manpower and equipment required to carry out the work.
- (b) The company must have a minimum experience of two years in similar work.
- (c) The company must have a turnover of minimum CHF 75,000/- during the previous three years.
- 4. The bid documents would comprise of the following:

- 5. All quotations should have date and signature of the authorized signatory of the service provider company with stamp.
- 6. PMI will not be responsible to compensate for any expense or losses which may be incurred by the Tenderer in the preparation and submission of his Tender.
- 7. Validity of the bids should be 6 months from date of opening of bids. Late bids and incomplete bids would be rejected.

8. The bidders must quote a lumpsum price inclusive of all services, personnel, material, transportation and other involved costs, but exclusive of TVA. The Mission reserves the right to reject any or all quotations without assigning any reasons thereof; and no inquiries in this regard would be entertained. The decision of the Mission would be final and binding on both parties in case of any disagreement.

- 11. The terms and conditions of the tender are as follow:
- (a) The PMI reserves the right to accept/reject the Bid and does not bind itself to accept the lowest Bid or any Bid and can reject any or all of the bids or to scrap the RFP in whole or in part without giving any notice or clarification.
- (d) The Mission would not accept any increase in the quoted price under any circumstances.
- (e) The company must obtain any required permission(s) from concerned authorities for execution of all the work under the Contact.
- (f) The company is liable for all the insurance, damage, theft, or loss of goods besides any damage caused to the property of the Mission during the execution of the work.
- (g) The company is responsible for the remuneration, insurance, safety and conduct of its staff assigned to the work and the Mission will not be involved or made party in any dispute of any nature arising between the company and its staff.
- (h) The price to be quoted by the Bidders shall be in Swiss Francs (CHF). The price shall include all taxes, miscellaneous services and duties. The prices quoted by the Bidder shall be kept open and valid for acceptance for a minimum period of Ninety (90) working days. Being a Diplomatic Mission, TVA is exempted. Therefore, all the rates quoted should be without TVA.
- (I) The Company must be registered under the relevant laws of the Canton of Geneva and should have all applicable/appropriate licenses in its name, compliance with relevant law and regulations of Swiss Government including labour law will be the sole responsibility of the company. They shall comply with all the requirements of taxes, fee and other statutory payment as are required by the concerned Swiss authorities
